

VISITOR'S ACKNOWLEDGMENT OF RISKS

In consideration of the services of **SOLITUDE FLOAT TRIPS, Inc.** their officers, agents, employees, stockholders, and all other entities associated with those businesses (hereinafter collectively referred to as "SFT") I agree as follows:

Although SFT has taken reasonable steps to provide me with appropriate equipment and skilled guides so I can enjoy an activity for which I may not be skilled, SFT has informed me this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of the activity. These inherent risks can be the cause of loss or damage to my personal property and equipment, or accidental injury, illness, or in extreme cases, permanent trauma or death. SFT does not want to frighten me or reduce my enthusiasm for this activity and I am aware of their safety record, but SFT, their insurance company and the National Park Service believe it is important for me to know in advance what could be expected and to be informed of the inherent risks.

The following describes some, but not all, of those risks: I acknowledge and willingly assume all risks and hazards in rafting and river-related transportation from the pre-determined meeting point until the conclusion of the trip, including, but not limited to, (1) loss of control of the raft, falls in, out, or about the raft, collision with other participants, equipment, other rafts, rocks, trees, and any portion of the interior of the raft, and any other man-made or natural obstacles, whether obvious or not; (2) judgment, decision-making and conduct of the guides; (3) submersion in water, drowning; (4) encounters with animals, wildlife and insects; (5) exposure to wilderness environment, extreme temperatures, extremely cold water, and inclement weather, remote areas, wilderness terrain, including travel by foot or vehicle in any way related to this activity, whether at launch ramp or elsewhere; (6) assistance in lifting and/or carrying rafting equipment; (7) rescue-related injuries; and (8) unavailability of immediate and appropriate medical attention in case of injury; (9) SFT is not able to make any guarantees of reducing potential exposure to COVID-19 or of the elimination of COVID-19 or other pathogens.

I am aware that a scenic float trip on the Snake River entails risks of injury or death to any participant. I understand the description of these inherent risks is not complete and that other unknown or anticipated inherent risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein and those inherent risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks. I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of SFT has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity. I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself (including all minor children in my care, custody, and control) for bodily injury, death, or loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified and as a result of my own negligence while participating in this activity.

I have carefully read, clearly understood and accepted the terms and conditions stated herein, and acknowledge that this agreement shall be effective and binding upon myself, my heirs, assigns, personal representative and estate and for all members of my family including minor children.
